**Note:**

1. In case any candidate(s) fail to show requisite original documents at time Original Document verification his/her candidature will be treated as cancelled and no further correspondence will be entertained in this regard.
2. The candidature of the shortlisted candidates for Document Verification is purely provisional subject to verification and fulfilment of the eligibility criteria with regard to age, category, essential qualification and experience etc. as per the advertisement and Rules & regulation of the Institute.
3. In case any of the selected candidates who if found not fulfilling any of the eligibility criteria, at any stage then his/ her candidature /selection will be treated as cancelled without giving any reason. The final decision of The Executive Director, AIIMS, Rajkot in this regard shall be final and binding.
4. The degree/diploma qualification as claimed by the candidates is /are to be recognized by the concerned Government agency. The candidates have to submit documentary proof to the authority of the AIIMS, Rajkot, that the Government Authority recognizes the same. If anyone fails to submit documentary evidence, then his/her candidature will be cancelled without giving him/her any further opportunity. Similarly, while claiming any qualification equivalent to a degree /diploma, the candidate must submit documentary proof.
5. AIIMS, Rajkot will not defray your traveling and other expenses for the above-said document verification.
6. Document verification may also continue on the next working day. Candidates are advised to come with preparation to stay for the next day accordingly.
7. The list is purely provisional and may vary (both inclusion and exclusion) subsequently after detailed examination/verification. The decision of the Competent Authority in this regard will be final.
8. Candidates should note that shortlisting for Document Verification does not entail any right to issue an appointment letter. Those candidates who are in Govt. Service (including AIIMS Employees) are required to produce a No Objection Certificate (NOC) at the time of Document Verification; without the same, their candidature will be cancelled.
