- b) Proof of Essential Educational Qualification (Original, Provisional, Degree, Diploma, Certificate) along with Proof of Date of Result Declaration/Issue of Certificate.
- c) Registration Certificate as Grade "A" Nurse or Midwife from State/Indian Nursing Council.
- d) Experience Certificates in case of Diploma (GNM) Holder clearly indicating Number of Beds of Hospital and Duration of Experience.
- e) NOC -Candidates are required to upload NOC who are currently working in Central/State/PSB/PSU bodies.
- f) Valid Category Certificate for SC/ST/OBC/EWS.
- g) PwBD Certificate showing extent of disability issued by authorized/competent authority.
- h) Registration Slip of online registration having Candidate Signature.
- i) Admit Card having Candidate Signature.
- j) Copy of original ID Card for proof of Identity issued from any government Authority.
- k) Latest Photograph
- l) Standard Declaration (Form A)
- m) Copy of Address proof issued by any government authority like Electricity Bill, Ration Card, Voter Card etc.

Candidates who fail to upload & produce valid category certificate (OBC/EWS/SC/ST/PWBD etc.), during document verification, as per claimed category in registration form, candidature will not be

considered. In this case allocated reserve category seat will be cancelled and eligibility in subsequent round (if any) shall be subject to cut off rank of unreserved category.

#### Valid Category Certificate

a) OBC certificate/Non creamy layer certificate in English/Hindi, in the format provided by the DoPT vide OM No. 36036/2/2013-Estt.(res.) dated 30.05.2014 and further clarification issued by DoPT OM No. 36036/2/2013-Estt.(res.I) dated 31.03.2016 for appointment to the post under Government of India/Central Government format is required.

b) The vacancies were advertised in financial year 2023-2024, therefore, valid NCL-OBC certificate issued during the period **from 01.04.2023 to 31.03.2024** will be considered valid. Candidature who have NCL-OBC certificate issued before or after this period (i.e. 01.04.2023 to 31.03.2024), will not be considered valid for this advertisement. Candidates applying under OBC category must produce the valid caste certificate in the format provided by the DoP&T vide O.M. No. 36036/2/2013-Estt. (Res.) dated 30.05.2014 and further clarification issued by DoP&T OM No. 36036/2/2013-Estt(ResI) dated 31.03.2016. Certificate must be valid for employment in Central Government Institutions. OBC candidate's eligibility will be based on Castes borne in the Central List of Govt. of India. Their Sub-caste should also match with the entries in Central List of OBC, failing which their candidature as OBC candidate will not be considered. The OBC certificate should clearly show that the applicant does not belong to the Creamy Layer.

c) The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuineness of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the closing date for receipt of application for the post, except in cases where date is fixed otherwise. Accordingly, a EWS certificate issued in prescribed format for employment in Central Government on the basis on income of financial year 2022-2023 issued after 01.04.2023 but not later than 31.03.2024 valid for the year 2023-2024 will be considered valid.

d) Certificate for Persons with Benchmark Disability issued from a duly constituted and authorized Medical Board as mentioned in the prospectus

e) For Persons with Disability, Disability Certificate issued by duly constituted and authorized Medical Board in the proforma prescribed by the Department of Personnel & Training Vide O.M. No. 36035/3/2004-Estt. (Res. ) dated 29.12.2005. As the "Rights of Persons with Disabilities Act, 2016" has come into force with effect from 19.04.2017, and beside OH, HH and VH categories, new category of disabilities such as Autism, Dwarfism, Acid Attack victims, Muscular Dystrophy, Intellectual Disability, Specific Learning Disability, Mental Illness and Multiple Disabilities, etc have been included. The post of Nursing officer is identified for OL, AAV, Dw and LC (OL) category, that the candidates with such disabilities may apply for the post identified under PWBD quota and mentioned against such posts. Please see the respective section 22 in General Conditions for detail. Abbreviations of above categories are as under:- LD= Locomotor Disabilities : OL=One Leg, LC(OL)= Leprosy Cured(One Leg), Dw= Dwarfism, AAV=Acid Attack Victims (Category (c)).

**Note:**

1. In case any candidate(s) fail to show requisite original documents at time Original Document verification his/her candidature will be treated as cancelled and no further correspondence will be entertained in this regard.
2. The candidature of the shortlisted candidates for Document Verification is purely provisional subject to verification and fulfilment of the eligibility criteria with regard to age, category, essential qualification and experience etc. as per the advertisement and Rules & regulation of the Institute.
3. In case any of the selected candidates who if found not fulfilling any of the eligibility criteria, at any stage then his/ her candidature /selection will be treated as cancelled without giving any reason. The final decision of The Executive Director, AIIMS, Rajkot in this regard shall be final and binding.
4. The degree / diploma qualification as claimed by the candidates is /are to be recognized by the concerned Government agency. The candidates have to submit documentary proof to the authority of the AIIMS, Rajkot that the same is recognized by the Government Authority. If anyone fails to submit documentary evidence, then his/her candidature will be cancelled without giving him/her any further opportunity. Similarly, while claiming any qualification as equivalent to degree /diploma, then the candidate will have to submit documentary proof in this respect.
5. AIIMS, Rajkot will not defray the travelling and other expenses to you for above said document verification.
6. Document verification may also continue on the next working day. Candidates are advised to come with preparation to stay for next day accordingly.
7. The list is purely provisional and may vary (both inclusion and exclusion) subsequently after detailed examination/verification. The decision of the Competent Authority in this regard will be final.
8. Candidates should note that short listing for Document Verification does not entail any right for issuing appointment letter. Those candidates who are in Govt. Service (including AIIMS Employee) are required to produce No Objection Certificate (NOC) at the time of Document Verification, without the same, their candidature will be cancelled.

**Annexure- II**

Important Explanation for PWBD Candidate:

• PWBD candidates with disabilities mentioned in Section 34 (1) of Rights of Persons with Disability Act, 2016, and as identified by the Institute for OL, AAV Dw and LC (OL) following reservation under PWBD are eligible to apply under this category provided they have benchmark disability of equal to or more than 40%.

Abbreviations of above categories are as under: -

LD= Locomotor Disabilities: OL=One Leg, LC(OL)= Leprosy Cured (One Leg), Dw= Dwarfism, AAV=Acid Attack Victims (Category (c))

Please see the Notice regarding identification of posts suitable for PWBD as per guidelines of Govt of India at URL <https://www.aiims.edu/images/pdf/notice/rectt-16-3- 20.pdf>.

• As per Section 2(r) “person with benchmark disability” means a person with not less than forty per cent of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. Accordingly, for posts identified suitable for PWBD quota and as indicated against posts reserved for them, applicant should make sure that they are eligible and has desired/required disability certificate.

• After any candidate qualifies the interview/written examination/, such candidates will be subjected to medical examination by a board constituted by AIIMS to ascertain their suitability for the said post/job.

• As per DOPT office memorandum No. No.36035/02/2017-Estt (Res) dated 15.01.2018 Same relaxed standard should be applied for all the candidates with Benchmark Disabilities whether they belong to Unreserved/SC/ST/OBC/EWS. No further relaxation of standards will be considered or admissible in favour of any candidate from any category whatsoever.
