4. No Objection Certificate (NOC) for candidates working in Central Government/ State Government/ Autonomous bodies of Govt. of India is mandatory.
5. Participation in Interview does not guarantee selection. The proceedings of the SSC are confidential and the methodology adopted by the SSC for selection of the candidates is at the discretion of the committee. No information pertaining to the proceedings of the SSC shall be divulged to any candidate at any stage. Only such candidates who are agreeable to the above condition may appear for document verification and for Interview before the SSC.
