- In Accordance with terms of the above referred OMs, all the employees of AIIMS Rajkot shall get enhanced DA @ 50% of the Basic Pay & enhanced Other Related Allowances by 25% from their current admissible amount (Dress Allowance, Children Education Allowance & Hostel Subsidy, Deputation (Duty) Allowance, Nursing Allowance, Hospital Patient Care Allowance & House Rent Allowance) with effect from 1<sup>st</sup> January 2024.
- The arrears will be disbursed in due course of time.
