# Subject: - Publicity to Dr.Panjabrao Deshmukh SARTHI Higher Education Domestic Scholarship Scheme regarding...

Chatrapati Shahu Maharaj Research Training and Human Development Institute, Pune has been registered on June 2018 under Section 8 of the Companies Act, 2013 for the social, educational and economic development of the target groups of Maratha, Kunbi, Kunbi-Maratha and Maratha-Kunbi in the state of Maharashtra. This organization is working in Pune under the planning department of Maharashtra government. The president of this organization is Hon. Mr. Ajit Nimbalkar (I.A.S. Retired)

In the meeting of the Boad of Directors on 15.09.2022 of Sarthi Sanstha has approved to start Dr. Panjabrao Deshmukh Sarathi Higher Education Domestic Scholarship Scheme from the year 2022-23 for 300 students from target groups. Eligible students belonging to the target groups who are enrolled in reputed 200 Universities / Colleges in India will be given the benefit, subject to the following terms and conditions.

#### The benefits to the students under this scholarship will be as follows:-

(A) The full tution fees, examination fees, registration fees, gymkhana, library, computer etc. fees decided by the concerned University/Educational Institution for the course for a student eligible for Dr. Punjabrao Deshmukh Sarathi Higher Education Domestic Merit Scholarship will be deposited in the account which is linked to Aadhar Card of the concerned student through the concerned University/Educational Institution. The relevant student should be submit the proof of amount paid to the University / Educational Institution to the relevant institution.

- (B) Students staying in hostels of the concerned University/Educational Institution shall be entitled to deposit the fees charged by the institution as well as the session wise amount of food charges in the account which is linked to Aadhar of concerned student.
- (C) Students staying elsewhere due to lack of space in the hostel will be eligible to deposit the amount of hostel fees food amount in the account which is linked to Aadhar of concern student within the limit of the amount levied by the concerned institution (hostel fee and meal amount).
- (D) Eligible students under the scheme will be paid ₹ 25,000/- for course books and educational materials as well as other educational expenses will be paid Rs.25000/- totaling ₹ 50,000/- will be paid to the concerned student every year in two installments to his Aadhaar linked bank account. It will be mandatory to submit the details for this through the concerned educational institution to the Sarathi office in the prescribed format.

Students who are residents of Maharashtra state and whose parents have total annual income from all means Rs. Less than 8 lakhs (Non Cremylayer) This scholarship will be given to deserving students belonging to the target group. Advertisement of this scheme has been published in Marathi newspapers on 07/10/2022 and notice has been published on Sarthi Sanstha's website <a href="https://sarthi-maharashtragov.in/">https://sarthi-maharashtragov.in/</a>.
